

**INVESTMENT OBJECTIVE**

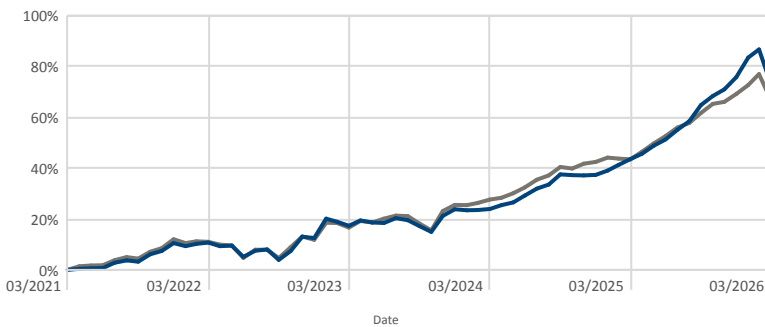
The PrivateClient BCI High Equity Fund is a multi-asset high growth portfolio with the objective to provide investors with superior capital growth over the medium to long term.

**INVESTMENT POLICY**

The portfolio's net equity exposure will range between 0% and 75% of the portfolio's net asset value. It may invest in equity securities, interest bearing securities, property shares, property related securities, preference shares, money market instruments, non-equity securities and assets in liquid form. The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may include the following unlisted financial instruments: forward currency, interest rate and exchange rate swap transactions.

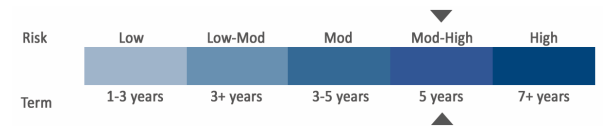

**Moderate - High Risk**
